



## Terms of Agreement

After hereby signing this written business agreement, you, \_\_\_\_\_, (Hereinfter "the client") has employed *Entertainment and Sounds Unlimited Inc.* (Hereinafter "ESU DJs") to provide Disc-Jockey Entertainment services for the following date(s) \_\_\_\_\_. **Initial:** \_\_\_\_\_. ESU DJs will supply all the necessary music, sound, lighting and multi-media equipment contracted for the event. We require that **Music Request Forms** be submitted **21 days** prior to the event by the client. ESU DJs is free from the responsibility of supplying music not requested prior to the 21-day period from the client.

In the event of sickness or hospitalization, the scheduled team member may and will be replaced with another Disc-Jockey of equal caliber. In the event of inclement weather, (i.e. nor'easter, blizzard, etc.) *ESU DJs Inc.* may not be held liable for any degree of tardiness due to traffic or road conditions. If an event is cancelled due to inclement weather, the company is free from any rescheduling difficulties that may arise. However, be reassured that *Entertainment and Sounds Unlimited Inc.* will make every effort to suit the needs of the client when rescheduling the event.

The deposit is **NONREFUNDABLE** since the company establishes this time/date and the Disc-Jockey team, for only this event. All deposits are to be made by credit card, check or cash. All final payments must be paid in full within **7 business days of the event by cash or certified check only**. Checks should be made payable to ESU Disc-Jockey Service. In the event of cancellation within a 72 hour period prior to the event, the client is responsible to pay 75% of the total booked fee of the event.

A **standard overtime rate** of \$\_\_\_\_\_ per hour, **Initial:** \_\_\_\_\_ will be charged if the client requests additional time. This rate can be modified in accordance with the overtime rate if the client requests only a part of an hour. Overtime can only be requested in ½ and full hour intervals.

The client is **responsible for any damages** to sound, lighting, audio/visual, mechanical hardware, novelty items, and costumes incurred by any one not authorized by the Disc-Jockey. ESU DJs is not responsible for any technical difficulties that may occur with DVD/Photo Montages not created by the ESU DJ Studio. In the event of hassling or subjective arguing with the Disc-Jockey due to intoxication of a client, guest, or group at the affair, *Entertainment and Sounds Unlimited* has the right to shut down operations until (1) the person is settled down and (2) the person is removed from the room. If these standards are not met, the company can break down equipment and leave the event at that time.

The client **must provide dinners** for the Disc-Jockey team and a location for the team to eat. This would be greatly appreciated by the members of the ESU Disc-Jockey Team.
